FLUID MOTION® is a food supplement containing glucosamine, chondroitin sulfate, bromelain, vitamin C, copper, and zinc, with hyaluronic acid and high-quality concentrated turmeric extract.

Vitamin C contributes to the protection of cells from oxidative stress (antioxidant effect)⁴ and supports normal collagen formation³ for the regular function of cartilage¹ and bones.

Bromelain, a proteolytic enzyme, is combined with glucosamine, hyaluronic acid, and chondroitin sulfate to offer a particularly comprehensive formula.

FLUID MOTION® also provides copper and zinc, components of coenzymes actively involved in cartilage¹ metabolism. Copper, in particular, helps maintain normal connective tissues².

FLUID MOTION® is gluten-free and therefore suitable for individuals with celiac disease or gluten intolerance.

INFORMATION

Cartilage atrophy is a condition that affects a significant portion of the more mature population. This degeneration often results in reduced joint space, manifesting as joint pain. The underlying cause is often repeated microtraumas, which are exacerbated by repetitive sports movements. Additionally, an unfavorable anatomical condition and suboptimal biomechanics can worsen the situation. Typically, pain appears around the knee—cap—at rest, during exertion (e.g., contracting the qua-

driceps, going up or down stairs), and under pressure. Restoring joint mobility can also be supported through the use of active substances that “nourish” the cartilage (e.g., glucosamine, chondroitin sulfate, galactosaminoglycuronoglycan, hyaluronic acid), potentially helping to reduce or alleviate symptoms linked to its deterioration.

INDICATIONS

Useful for the normal function of cartilage and for maintaining normal connective tissues, thanks to the presence of Vitamin C and Copper.

HOW TO USE AND RECOMMENDED DAILY DOSE

It is recommended to take 2 capsules per day.

Glucosamine sulfate 2KCl (**from shellfish**), Inulin, Bulking agent: Hydroxypropyl methylcellulose; Chondroitin sulfate, Zinc gluconate (Zinc), L-ascorbic acid (Vitamin C), Hyaluronic acid (Sodium hyaluronate), Bromel-

lain 2500 GDU/G, Turmeric (Curcuma longa L., rhizome) dry extract standardized to 95% curcuminoids; Copper diglycinate (Copper), Anti-caking agents: Magnesium salts of fatty acids, Silicon dioxide.
